Advocate for Professional Counseling!

For those interested in advocacy, there are currently a few good opportunities to contact your Senators and Representatives. Here are a couple bills relevant to boosting mental health services and helping the field become more effective.

H.R. 1109 The Mental Health Services for Students Act

Congressional Mental Health Caucus Co-Chairs, Reps. Grace F. Napolitano (D-CA) and John Katko (R-NY), along with 56 original co-sponsors, proudly introduced H.R. 1109, the Mental Health Services for Students Act, to fund on-site mental health services for youth in schools nationwide. This bill would increase federal funding for therapists and mental health services in schools. Having these services in place can help students treat mental health concerns before they become unmanageable, rather than relying on crisis intervention.

Mental Health Access Improvement Act

Senators Barrasso (R-WY) and Stabenow (D-MI) have reintroduced a bill in the Senate to enable LPCs to accept Medicare. This would increase access for senior citizens and is especially relevant to the AADA. Additionally, due to the high level of opioid use by senior citizens, better access to mental health services for the elderly could help deal with the opioid crisis. Rep. Thompson (CA-05) and Rep. Katko (NY-24) also reintroduced the bill in the House, so it looks like there could be some momentum growing with this one. If you're contacting a Senator, make sure to mention Senate Bill 286 in your communication.
